Functions of MHRBs.

- 1. Review after, modify, or cancel advance directories.**
- 2. Appointment of nominated representatives.**
- 3. Appointment of nominated representative of the minor.**
- 4. Giving permission for continuance of admission, re-admission and discharge of person.**
- 5. Issue order on violation of rights of Patient with mental illness.**
- 6. Adjudicate complaints regarding deficiencies in care and service.**
- 7. Admission of minors and women shall be informed by the Medical Officer to the concerned Board.(3/7-day time frame).**
- 8. Visit and interview the minor, if requires so.**
- 9. Mandatory review of admission of minors continuing beyond 30 days (7-day time frame).**
- 10. Transfer of patient with mental illness (Minor/high need support/beyond 30 days/prisoners)**
- 11. Permission for ECT and Psychosurgery for minors.**
- 12. Visit prison or jail.**
- 13. Boards role in instance of restraint of mental health patient.**
- 14. Proof of Mental illness in judicial process to be verified by the Board.**
