Later vide Government Order read as 3rd paper above, it was ordered to implement the KASP scheme in an assurance mode where the claim of private hospitals alone will be serviced by a third party administrator/Implementation support agency.Hence vide Government Order read as 4th paper above it was decided to form the evaluation committee for the evaluation of the tender floated on the 3rd of May,2020 under assurance mode.As the Government has decided that the selected TPA/ISA has to outsource the claims of public hospitals as well.The Executive Director, State Health Agency vide Letter read as 5th paper above has requested the Government to amend the former order read as 4th paper above to modify the evaluation committee for the tender floated on 24th December 2020 and also as suggested as the bid opening of the current tender is already scheduled on 11th of January 2021.
