ORDER

As per Government Order read as 1st paper above, Government of Kerala have constituted a High Level Committee for the evaluation of tenders for Karunya Arogya Suraksha Padhathi for the year 2020-21. Later vide GO read as 2nd paper above, Government have modified the committee under assurance mode for the evaluation of technical bids for the selection of Third Party Administrator/Implementation Support Agency [TPA/ISA] to outsource the AB PMJAY – KASP claim processing of private/public Hospitals. Vide G O read as 3rd paper above, orders were issued for the approval of tender 2020-2021 for the selection of TPA/ISA and sanction accorded for awarding the contract from 01.07.2020 to 30.06.2021. As per the Note read as 4th paper above. Executive Director, State Health Agency has informed that they had now initiated the tender process for the selection of TPA/ISA for outsourcing the claim of private hospitals and the bid has already been floated . Since the contract period of TPA/ISA will expire on 31.07.2021, they have requested for an evaluation committee for tender.
