ORDER

As per Government Order read as first paper above, Government have implemented 'Arogya Suraksha Padhathi (KASP) - Pradhan Mandri Jan Arogya Yoj na (PMJAY) in the State as an Assurance mode. As per letter read as 2nd and 3rd paper above, the Executive Director has informed that during the financial year 2020-21 first Quarter (01 April 2020 to 30 June 2020) was implemented through insurance mode and total claim submitted by various hospitals during the period is Rs. 111 Crores. As such, the same amount can be anticipated for the second Quarter also and the maximum amount receivable from the Central Government is Rs. 138.10,61,182/- a year, (Central Guidelines attached) therefore the maximum amount expected from the Central Government in a Quarter is Rs.34.52 Crores. Therefore the balance amount is to be met by the State Government (Rs. 76.48 Crores). The Executive Director, SHA has assured to furnish the detailed family wise claim details to Government after completing the 2nd Quarter. He has also requested to sanction an amount Rs. 76.48 Crores to State Health Agency at the earliest for proceeding with the scheme (Rs. 35.95 Crores from the Head of Account 2210-06-800-80 and Rs. 40.53 Crores from the

Government have examined the matter in detail and are pleased to sanction an amount of Rs.35.84 cr under the h/a 2210-06-800-80-PMJAY/KASP (40% State Share) (P) (₹76.48cr - ₹40.64 Cr(pl see pg.no.24 AD CF)= Rs.35.84cr) to the escrow account mentioned below by the State Health Agency towards KASP - PMJAY Scheme State Share for Second quarter of 2020-21.
