ORDER

As per Government Order read as 2nd above sanction was accorded to release Rs.56,88,14,792/- (Rupees Fifty Six Crores Eighty Eight Lakhs Fourteen Thousand Seven Hundred and Ninety Two Only) from the Head of Account 2210-06-800-80-PMJAY/KASP-CSS-02-State Share-(P) and Rs. 83,76,46,400/- (Rupees Eighty Three Crores Seventy Six Lakhs Forty Six Thousand and Four Hundred Only) from the Head of Account 2210-06-800-81-PMJAY/ KASP State Scheme(P) towards the payment of insurance premium payable to M/s Reliance General Insurance Co. Ltd., as part of extension the AB-PMJAY/KASP policy period for a period of three months (i.e., from 01/04/2020 to 30/06/2020).
