**ORDER**

The State Government vide order read as first paper above, has accorded sanction for hiring the services of a TPA/ISA [till SHA builds its capacity] by modifying the existing tender documents for the forthcoming policy year 2020-21 (starting 01/07/2020). Accordingly a Tender Evaluation Committee was formed as per Government order read as 2<sup>nd</sup> paper above for the evaluation of tender floated on the 3<sup>rd</sup> of May, 2020. In the meeting held on 20-05-2020 the evaluation committee opened and verified the Technical bids and had found all the bids to be complete and responsive. The committee evaluated the bids of TPA/ISA and the rates quoted by them are as follows.
