As per Section 73 of the Mental Health Care Act, 2017 (No. 10 of 2017), the State Authority shall by notification constitute boards to be called Mental Health Review Boards for the purpose of the Act and Section 74 provides for the composition of the Boards. As per Notification No. A/217/2017/KSHMA dated 25-1-2021, the Kerala State Mental Health Authority in consultation with the Government constituted 5 Mental Health Review Boards. The State Mental Health Authority has invited applications for the selection of Chairpersons and the Chief Executive Officer of the Authority prepared a panel of eligible applicants to the post of Chairpersons and members of the Review Boards. The Selection Committee constituted by the Government selected suitable candidates from the panel. Hence, the State Mental Health Authority decided to appoint the selected candidates.

This notification is intended to achieve the above objects.

In exercise of the powers conferred by sections 73 and 74 of the Mental Healthcare Act, 2017 (Central Act 10 of 2017) read with rule 17 and 18 of the Mental Healthcare (Central Mental Health Authority and Mental Health Review Boards) Rules, 2018, the Chairman, Kerala State Mental Health Authority hereby appoint Dr. Shalima, S., Kairali House, Karoor, Ambalappuzha P.O., Alappuzha-688 581 (Assistant Professor in Psychiatry, Government Medical College, Alappuzha) as member of Mental Health Review Board, Thiruvananthapuram in place of Dr. Ravikumar, K., Nirmalyam, Pattathanam P. O., Kollam-691 021, constituted as per Notification No. A/217/2017/KSMHA dated 22nd June 2022 in the Kerala Gazette Extraordinary No. 2132 dated 27th June, 2022 and consequently make the following amendment to the said notification, namely,

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Under section 73 of Mental Healthcare Act, 2017 (Central Act 10 of 2017), the Kerala State Mental Health Authority in consultation with the Government constituted 5 Mental Health Review Boards as per Notification No. A/217/2017/KSMHA dated 25th January, 2021. The Chairperson and members of the Mental Health Review Boards have been appointed as per Notification No. A/217/2017/KSMHA dated 22nd June, 2022. Dr. Ravikumar, K. who was appointed as Member of Mental Health Review Board, Thiruvananthapuram tendered his resignation on 15th June, 2024. The State Mental Health Authority invited application from eligible applicants to fill up the aforesaid vacancy. The Government constituted a selection committee to select suitable candidate based on merit. As per G. O. (Rt.) No. 1570/2025/H&FWD dated 5th June, 2025 Government have selected and appointed “Dr. Shalima S., Kairali House, Karoor, Ambalappuzha P. O., Alappuzha—688 581 (Assistant Professor in Psychiatry, Government Medical College, Alappuzha)” as Member of Mental Health Review Board, Thiruvananthapuram, in lieu of Dr. Ravikumar, K. Hence, the State Mental Health Authority decided to appoint the selected candidate to discharge the functions as a member of Mental Health Review Board Thiruvananthapuram.

This notification is intended to achieve the above objects.
