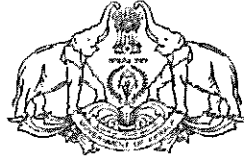

ORDER

The Government of India had recently announced the NHPS (National Health Protection Scheme) benefit package under Ayushman Bharat- Pradhana Mantri Jan Arogya Yojana (AB-PMJAY) in the place of the present RSBY Scheme which aims to provide secondary and tertiary coverage upto Rupees 5 Lakh. As per the Government Order read 1<sup>st</sup> above, Government of Kerala had decided to implement Ayushman Bharat- Pradhana Mantri Jan Arogya Yojana (AB-PMJAY) in the State with effect from 01.04.2019 as Karunya Arogya Suraksha Padhathi (KASP) by combining the existing CHIS PLUS and Karunya Benevolent Fund Schemes into a common comprehensive Health Protection Scheme which would assign with NHPS. As per the Government Order read 2<sup>nd</sup> above, CHIAK was designated as the State Health Agency for its implementation. As per the Government Order read 3<sup>rd</sup> above Dr. Rathan U Kelkar IAS was appointed as Special Officer of Karunya Arogya suraksha Padhathi.

The Karunya Arogya suraksha Padhathi, being a prestigious insurance scheme of the Government of Kerala and since there are lot of changes between the old scheme and the new Insurance Scheme, Government are pleased to streamline the work as follows which will come into existence with immediate effect .

1. Special Officer, Insurance will be the over all incharge of Insurance programme in the State including Government officers' Insurance Scheme.
2. Special officer, Insurance will study the structures and processes and submit the detailed proposal for strengthening State Health agency to make it a professional organization.
3. Executive Director, CHIAK will be responsible for the follow up legacy issues related to RSBY, CHIS PLUS and Karunya.
4. All matters related to KASP and Government Officers' Insurance Scheme will be handled by Special Officer, Insurance.

5. Special Officer, Insurance will develop the systems of Monthly Progress Report and Quarterly Progress report to inform all the aspects with respect to Insurance.
6. Executive Director, CHIAK will develop a system of Monthly Progress Report and Quarterly Progress Report to inform all the details regarding RSBY /CHIS plus/ Karunya schemes legacy issues.
