ORDER

Government as per the order read as 5th paper have issued guidelines for implementation of the "Sruthitharangam" scheme through State Health Agency.

2. As requested by the Executive Director, State Health Agency vide letter read as 4th paper above, Government are pleased to issue the following orders:-

(i) After proper scrutiny and up on the recommendation of the State Level Technical Committee, the State Health Agency shall empanel hospitals (Public and Private Hospitals) under Sruthitharangam scheme for its better service delivery. Till the completion of process of empanelment of hospitals by the State Health Agency, it can use the hospitals that are already empaneled by Kerala Social Security Mission

(KSSM) to provide services for the Sruthitharangam scheme.

(ii) Kerala Medical Services Corporation Ltd (KMSCL) to identify the vendors for implant under Sruthitharangam scheme as per the specifications provided.

(iii) Empaneled hospitals to procure implants by following the Stores Purchase Manual until the tendering process through KMSCL is completed.

(iv) All public hospitals are directed to utilise the funds received under the 'Sruthitharangam' scheme only for smooth running of the scheme such as appointment of human resources, procurement of implants and consumables .

(v) The existing State Level Technical Committee constituted vide Government Order read as 1st paper is modified by including, Assistant Professor(Audiology, Government Medical College, Kozhikkode) and Audiologist(National Institute of Speech and Hearing (NISH), Thiruvananthapuram) as members. Also, t he Head of Department, Department of ENT, Government Medical College, Kottayam mentioned in the State Level Technical Committee is renamed as Professor, Department of ENT, Government Medical College , Kottayam and the Government Order read as 1st paper above is modified accordingly.

3.The Government order read as 1st paper above stands modified to above extent only.
